Date: Wednesday, 1st January, 2025 **Subject:** Competitive Permit Conditions

Motorcycling NT (MNT) provides the following snapshot of the new requirements and conditions for competitive permits to its affiliated clubs and promoters.

CLOSED TO CLUB PERMITS

Permit Fee: \$160.00 per day

Rider Levy Fee: \$ 13.00 per competitor – Motocross

\$ 10.00 per competitor – all other disciplines

Permit Length: 48 hours

Can only be held by an affiliated MNT club (no private promoters)

- One event licences permitted
- May include a demonstration class
- Participants must hold a current annual membership with the host club
- All Key Officials minimum Level 2 (Steward to be allocated by MNT)
- Not permitted within 8 days from the start of any on track activities for any State competitive event
- No livestreaming
- No spectator ticket sales
- No prize money

INTERCLUB PERMITS

Permit Fee: \$170.00 per day

Rider Levy Fee: \$ 13.00 per competitor – Motocross

\$ 10.00 per competitor – all other disciplines

Permit Length: 72 hours

- Can only be held by an affiliated MNT club (no private promoters)
- One event licences permitted
- May include a demonstration class
- Participants must hold a current annual membership with one (1) of the six (6) clubs
- Key Officials minimum Level 2 (Level 3 Steward to be allocated by MNT)
- Not permitted within 8 days from the start of any on track activities for any State competitive event
- No livestreaming
- Spectator ticket sales allowed
- Senior prize money only

OPEN CLUB PERMITS

Permit Fee: \$200.00 per day

Rider Levy Fee: \$ 23.00 per competitor – Motocross

\$ 20.00 per competitor – all other disciplines

Permit Length: 96 hours

- Can only be held by an affiliated MNT club (no private promoters)
- Annual licence holders only
- May include a demonstration class
- All Key Officials minimum Level 3 (Steward to be allocated by MNT)
- Not permitted within 8 days from the start of any on track activities for any State competitive event
- Final Instructions required
- Programme required
- Live timing required
- Livestreaming allowed
- Spectator ticket sales allowed
- Prize money allowed

OPEN STATE PERMITS

Permit Fee: \$250.00 per day

Rider Levy Fee: \$ 25.00 per competitor – Motocross

\$ 20.00 per competitor – all other disciplines

Permit Length: 96 hours

- Can be held by the SCB, affiliated club or a private promoter
- No club related activities 8 days prior
- Annual licence holders only
- Demonstrations, special events or activities must be listed in Supplementary Regulations
- All Key Officials minimum Level 3 (Steward to be allocated by MNT)
- Not permitted within 8 days from the start of any on track activities for any State competitive event
- Final Instructions required
- Programme required
- Live timing required
- Livestreaming allowed
- Spectator ticket sales allowed
- Prize money allowed

COMPETITIVE PRACTICE PERMITS

Permit Fee: \$100.00 per day **Rider Levy Fee:** \$ 10.00 per competitor

Permit Length: 24 hours

- Can be held by an affiliate MNT club or a private promoter
- If **practice is associated with a competitive event** officials will be required to be at the same level over both events. **Eg.** If competitive event is an open permit, the practice would require minimum Level 3 officials
- If **practice** is a stand-alone event, minimum official requirement will be as per conditions of participation **Eg**. If entries are closed to club members only, requirement of official would be Level 2 officials.
- In the instance where both Competition Licence holders and Recreational Licence holders participate, the Competition Licence holders must not be grouped with Recreational Licence holders.

PERMIT SUBMISSION and APPROVAL

All competitive events other than 'Open Events' must be submitted through RiderNet at least two (2) weeks prior to the proposed date. Competitive Open events must be submitted through RiderNet at least eight (8) weeks prior to the proposed date.

Club and **Interclub** permits will be approved within **3** business days and **Open** permits will be approved within **7** business days after submission through RiderNet.

For permits requiring approval outside of the above you will be required to contact the MNT Office and will incur a \$250.00 emergency approval fee.

NOMINATIONS

All nominations are to be submitted through RiderNet for any competitive events permitted by Motorcycling NT, no paper nominations or other electronic platforms are accepted.

ADVERTISING OF PERMITTED EVENTS

As per clause 3.9 of MNT affiliation agreements the MA and MNT logo is to be prominently displayed for all MA or MNT permitted events.

PERMIT DOCUMENTATION

Permit is to be prominently displayed at the venue, in addition to your certificate of affiliation and track licence.

Permit numbers are to be displayed in programmes and race orders.

INSURANCE

After your permit and supplementary regulations are approved, the event will be covered by Public Liability and Personal Accident insurance.

Please keep in mind that any changes made to the event or supplementary regulations that conflict with the MA track standards, Manual of Motorcycle Sports and/or the GCRs can void the insurance. In such cases, officials and promoters will be held liable.
